The Certified Internal Auditor (CIA) designation is the only globally accepted certification for internal auditors. The CIA credential is a master key to professional success and opening doors for career opportunities. ## How can I be certified as a CIA?

To be certified as a CIA, candidates must fulfill both educational and professional experience requirements as follows:-

- ◆ CIA candidates must hold a 4-year post-secondary degree (or higher) or its educational equivalent from an accredited university;
- ◆ A minimum of 24 months of internal auditing experience or its equivalent. A Master's degree can substitute for 12 of the required 24 months;
- ◆ **Pass the CIA Examination;**
